Rawalpindi Women University invites bids under **Single Stage One Envelope** national competitive bidding procedure from active tax payer reputable firms/contractors registered with relevant tax authorities (Professional tax, Income tax & Punjab Sale Tax), registered on Punjab e-Pak Acquisition and Disposal systems (EPADS) and also registered with Pakistan Engineering Council (PEC) in C-6 and above category & code of specialization for the following works:

- i. Bidding documents are available on EPADS portal i.e. www.punjab.eprocure.gov.pk, PPRA website i.e. www.ppra.punjab.gov.pk and Rawalpindi women University website i.e. www.rwu.edu.pk. The interested bidders/contractors/firms can download the bidding document free of cost.
- ii. Bids duly completed, signed/stamped, without any cutting/overwriting and in conformity with bidding documents along with the copy of Earnest Money, attested copy of PEC certificate, attested copy of Income tax & Punjab Sale Tax (PRA) certificate with active status, Professional Tax Certificate & Affidavit of nonblack listing must be submitted online on e-Pak Acquisition and Disposal systems (EPADS) website i.e. www.punjab.eprocure.gov.pk till **17-03-2026 before 09:30 am** and bids shall be opened on the **same day @ 11:30 am** in the presence of **Campus Construction Committee** and contractors/bidders or their representatives (with authority letter), who may care to be present at the opening date & time. Manual /telephonic or conditional bids will not be entertained.
- iii. The response time shall be calculated exclusively from the date of publication of the advertisement on the website of the PPRA i.e. <https://eproc.punjab.gov.pk/ActiveTenders.aspx>
- iv. Original bid security (Earnest Money) in the form of CDR/Bank Draft/ Pay order/Banker cheque in the name of **"Rawalpindi Women University"** (FTN/NTN # **9022136-5**) of the above mentioned amount along with the letter head, attested copy of PEC certificate, attested copy of Income tax & Punjab Sale Tax (PRA) certificate with active status, Professional Tax Certificate & Original Affidavit of nonblack listing must be submitted physically at the below mentioned address before **09:30 am on 17-03-2026**. Earnest money should be kept in separate envelope. Without these, the bid will not be entertained.
- v. Bidders are advised to ensure uploading bids on EPADS portal well before the submission deadline and not wait for the last date & time to upload the bid. Bid submission of EPADS portal shall be entirely responsibility of bidder. Rawalpindi Women University will not be held responsible for any such issues thereof.
- vi. Rawalpindi Women University may reject all Bids or Proposals at any time prior to the acceptance of Bid or Proposal as per PPRA clause 35 (1).
- vii. The firms/contractors shall be responsible for payment of all applicable taxes at the time of release of payment as admissible under the rules prescribed by the Government of Punjab.
- viii. PPRA rules amended up to date will be strictly applicable. In case of any violation, bid will be rejected as per rules.
- ix. In case of submission of any fake information/document such as CDR/Pay order, the contractor/firm will be disqualified from the tendering procedure and will be blacklisted to participate in any tendering process of Rawalpindi Women University. Further recommendation to PPRA & PEC will also be made against such firm/contractor for appropriate action/blacklisting.
- x. As per PPRA circular No. L&M (PPRA) 10-1/2011 dated: 11-10-2024, the bidder shall quote their rates against each entry/items of DNIT/ BOQs (Instead of percentage) and completely fill the pages of rate analysis/summary/sub summary in their financial bids. All incomplete financial bids (Blank DNIT/BOQs and blank entries/pages of rate analysis/summary/sub summary etc.) shall be declared as non-responsive.
